<b>Job Purpose</b>

<ul style="list-style-type: none"> <li>• Make strategic and operational decisions over the Modern Foreign Languages curriculum in all areas of the school, including additional intervention strategies where appropriate.</li> <li>• Assist in the development of appropriate curriculum, resources, schemes of work, marking policies and teaching strategies in Modern Foreign Languages.</li> <li>• Provide professional leadership to subject teachers of Modern Foreign Languages across the Key Stages.</li> <li>• Demonstrate a professional commitment to become the best teacher possible, utilising evidence-informed approaches of what works in our context.</li> <li>• Demonstrate an appropriate level of understanding and skill to utilise the strategies and expectations exemplified in TEAL’s Teaching Charter, and to maintain the relevant Teachers’ Standards at an appropriate career stage.</li> <li>• Adapt teaching to respond to the needs of all students, demonstrating an awareness of the physical, social and intellectual development of students and using effective teaching strategies that respond to individual needs.</li> <li>• Support a safe, calm and well-ordered environment for all students and staff, focused on safeguarding pupils and actively contributing to their personal development.</li> <li>• Hold and articulate clear values and moral purpose, focused on providing ambitious and inclusive education for all the students we serve.</li> <li>• Make accurate and productive use of assessment and providing students with meaningful feedback in line with the relevant feedback framework.</li> <li>• Actively support the implementation of the School Improvement Plan (and other relevant development priorities).</li> <li>• Ensure the implementation of all TEAL and school policies.</li> <li>• Engage effectively with parents, carers and members of the community to resolve complaints and develop constructive relationships that support the school in realising its aims and objectives.</li> <li>• Demonstrate the key values and behaviours commensurate with this post that are identified overleaf.</li> </ul>
